- Maintain cybersecurity while effectively providing services




### Technology Professional Development



### Cybersecurity Awareness

#### 2022-23 Status:



The Cybersecurity and Infrastructure Security Agency (CISA) is the federal lead for Cybersecurity Awareness Month with the National Cybersecurity Alliance (NCA) as co-lead.

Now in its 19th year, Cybersecurity Awareness Month is a collaborative effort between government and industry to raise cybersecurity awareness nationwide and help ensure that all Americans have the resources they need to be safe and secure online.

#### 2023-24 Status:

- October 2023 was the 20th annual Cybersecurity Awareness Month.
- We continue to work with staff and students in raising awareness and protection levels.
- This October also saw a review and tightening of trusted applications that can sign-in with Google.



### Cybersecurity Awareness - Password Security

#### 2022-23 Status:

#### **Use Strong Passwords**



- Creating strong passwords is an easy way to improve your cyber security. Strong
  passwords include one uppercase letter, one lowercase letter, at least one
  number and 11 or more characters. Be sure to use different passwords for
  different accounts.
- Use password managers to generate and remember different, complex passwords for each of your accounts. A password manager will encrypt passwords securing them for you!
- Put cybersecurity first by protecting the information stored on devices. Much of a user's personal information is stored either on their computer, smartphone, tablet or possibly someone else's system.



#### 2023-24 Status:

- CISA recommended password length has increased from 11 to 15 characters.
- ClassLink acts as a password manager for staff and students for applications by creating a Single Sign On (SSO) method.
- Staff and students should not use their district assigned account name and password for non-district third party accounts.



### Cybersecurity - Shields Up

- The steps from the previous slides seek to balance the needs of security and usability
- In February 2022, CISA advised all agencies and companies to operate with a Shields Up cybersecurity posture and we <u>still</u> continue to do so
