OLD BUSINESS

Dissection Protocol

The Superintendent updated the Board on the District's decisions regarding dissection protocol. This item had been brought up at a previous BOE meeting by a concerned student. After meetings with the Science Department it has been recommended that the District add a student contract, which combined with the opt-out option, should raise the level of behavior during dissections.

COMMITTEE REPORTS

Business Affairs

Mr. Saggese reported that the committee will meet February 24th to discuss budget development and continue the discussion on bussing. The District is looking at ways of streamlining and increasing efficiency with the contract that is coming up. Items to be discussed will be increasing the mileage to the state limits for pick-up and the referendum to accomplish that. This would reduce the cost by 14%. The second item would be centralized pick-up and drop-off of the private and parochial students with a savings of about 14%. The third item would be to increase the efficiency of our student load factor, with an estimated savings of 6%. The fourth item is looking at the possibility of in-house busses. Currently we operate eight buses; we are looking at another 10-11% reduction in that cost. Overall we are looking at a 30-35% decrease in transportation costs.

Mr. Carlin reported that the administration will be presenting their first go-round at budget building during tomorrow night's meeting. Mrs. Cahill added that Ms. Niles will be presenting the introduction to the budget process and then there will be a brief over-view of what we know to date. Following that there will be a very brief, condensed presentation on the instructional program since we lost a meeting due to snow.

Mrs. Waldron asked if Ms. Niles or her ASBO organization has heard anything from the state regarding state aid. Ms. Niles responded that BOCES had a presentation this morning about state aid which did not give any new information. The presentation did show that the Extended School Year Program which we run will not provide us the normal 80% funding. The new formula will have us paying 79%. This situation is similar to last year's MTA payroll tax. Mrs. Waldron stated that she had heard that it has been recommended that school boards start using examples of how many employees would be lost due to lower state aid. Mr. Saggese stated that it is his belief that at the budget meeting the administration will be showing a very substantial gap between budget revenue and expenditures for next year. Mrs. Waldron also asked that the BOE be provided with an updated listing of current unfunded mandates. Mr. Martella discussed a legislative breakfast he had attended at Longwood where legislators had asked for a listing of unfunded mandates that are placed upon school districts. Ms. Niles stated that a list of unfunded mandates was given to our legislators last year. Mr. Ehmann noted that if the funding formula is changed with regard to the Special Education Extended School-Year program, that would be another \$600,000 that we did not have to budget for last year.

Mr. Rossi added that it is important for the Superintendent to keep in touch with the local politicians to let them know on a daily or weekly basis what our concerns are and how these items are going to affect our school district.

Facilities

Mr. Liguori asked that a prioritized, complete listing of all projects which need to be done, with dollar amounts, be prepared for the BOE for the March 11th Facilities meeting.

Mrs. Waldron suggested that the District request that our local legislators work on our behalf to move some of the projects that are awaiting approval from Albany.

Finance

Discussion

Item #'s 5, 6 and & 7 – Mr. Carlin asked for the decision making behind the use of the ARRA funds for these three contracts. Mrs. Cahill responded that the existing ARRA funds are being applied to a number of different projects. Under Response to Intervention regulations there is a mandate to the school district to provide research-based instruction as part of our remedial program. We looked at providing in-service for our staff by providing some services provided by BOCES; we evaluated what it would cost if we kept them after work and had to pay them to be there. The way we are delivering this model, with the help of our building principals, is release time from their position for the dates noted and the delivery of six hours of in-service workshop. This was the most cost efficient and effective way to do this. Mr. Carlin asked if the administration had calculated the precise number of people who needed to be trained, and is that the precise number of people you are training. Mrs. Cahill responded that we are training the individuals who would be responsible to provide instruction; this is much fewer than the number of people we could potentially train. Mr. Carlin asked if it would be necessary to hire subs for these people. Mrs. Cahill responded that it depends on the group; for the tutors and reading teachers we did not bring in substitutes. For some of our Special Education teachers we did have to bring in some substitutes. The substitutes are also being paid for out of the grant. Mrs. Cahill added that these workshops were approved by New York State.

Item # 2 - Mr. Martella questioned Bid 09-54. After back-and-forth discussion it was decided to table this bid.
